ISO 20000-1 can apply to any organization wishing to implement processes and controls that enhance the effectiveness of IT service management and delivery. It is sector independent, and relevant to both public and private, internal or external organizations. Those organizations that feel ISO 20000 is a better fit for their business, and that are currently ISO 9001 certified, can easily upgrade at an upcoming audit event. ISO 20000-1 uses the same approach as ISO 9001 and ISO 27001, including the PDCA (Plan-Do-Check-Act) cycle for continual service improvement.

How does this work with my current registration(s)?

Separate requirements exist for your management system under the ISO 20000 standard from either ISO 9001 or ISO 27001. SRI recommends you purchase and thoroughly read the standard (available at www.iso.org), get training from SRI if needed, and develop a thorough implementation plan. SRI also offers integrated ITSMS, QMS, and Information Security audits, delivering more value at each event and saving time and expense. What does it cost?

Registration alone is similar in time and cost to a QMS registration.
